# Sierra Leone Multi-Partner Trust Fund

Amendment No. 2 to the Memorandum of Understanding between the International Organisation for Migration, and

the United Nations Development Programme regarding the Operational Aspects of the Sierra Leone Multi-Partner Trust Fund

WHEREAS, the Memorandum of Understanding (hereinafter referred to as "Memorandum") between the International Organisation for Migration (hereinafter "IOM") and the United Nations Development Programme, as Administrative Agent for the Sierra Leone Multi-Donor Trust Fund, (hereinafter "UNDP") was concluded on 21 October 2009 and amended on 25 February 2012;

WHEREAS, the Participating UN Organizations have concluded an Amendment No 2 to the Memorandum of Understanding relating to the Operational Aspects of the SL-Multi-Partner Fund on 25 March (attached hereto as Annex I) which has now been amended to end on 31 December 2014 in support of the Transitional Joint Vision for Sierra Leone from 2013 to 2014 as part of their respective development cooperation with the Government of Sierra Leone, as more fully described in the revised Terms of Reference of the SL-MPTF 2013-2014 dated 14 February 2013, (hereinafter referred to as the "TOR"), a copy of which is attached hereto as ANNEX II,

The Memorandum of Understanding between the International Organisation for Migration and the United Nations Development Programme (acting as Administrative Agent for the Sierra Leone Multi-Partner Trust Fund) is therefore modified as follows:

#### Agreement:

3. IOM agrees to carry out its activities on the terms and conditions of the Memorandum of Understanding and its Amendment No 2 entered into between the Participating UN Organizations and the UNDP MPTF Office attached hereto as Annex I, which is an integral part of this MOU.

All other terms and conditions of the Memorandum of Understanding remain unchanged.
