## 2. An Advocacy Plan for First 1000 Days of Nutrition:

A two day workshop was conducted to formulate an advocacy plan for the first 1000 days of nutrition. Officers from the Ministry of Health (MoH) (representing Nutrition Coordination Unit, Family Health Bureau, and Health Education Bureau), WFP, UNICEF, leading INGO, NGOs, and SUN PF council attended to the workshop and actively involved with the development of the advocacy plan.

#### 3. SUN PF Board Meeting:

The SUN PF board meeting was held on 17th February 2015 (Annex 3 - Minutes of the SUN PF Board Meeting).

## 4. Project Review and Planning meeting with SCI:

A project review and planning meeting was held with the Senior Manager Health & Nutrition, Save the Children International. The purpose of this exercise was to review the project achievements and plan activities for the current quarter and the year.

**2.** Strong civil society alliance supported and monitored the Sri Lanka multi sectorial action plan in accelerating "nutrition specific" "nutrition sensitive" interventions that with the appropriate budgetary allocation by the government and other stakeholders by 2015.

#### 1. A Video documentary on Nutrition:

A contract was signed to produce a documentary on improving Nutrition in Sri Lanka. The documentary is to be used as a resource material in the capacity building programs for Community based Organisations (CBOs)/ Civil Society Organizations (CSOs). This activity is currently on going. An additional feature of the documentary was to interview a cross section of officials working in the nutrition sector of the country. Interviews are planned with

MoH officials, Chairperson SUN PF council and few other officials.

#### 2. SUN PF website:

A website for SUN PF is being designed. Currently, the website development work is undertaken by an intern who volunteered to render his services for the task.

#### 3. SUN PF News Letter:

The first newsletter of SUN PF is being finalized.

# 4. Survey of violation of breast milk code, advertisements related to food, dietary diversity and food security:

As a part of SUN PF's responsibility towards monitoring nutrition related activities, an assessment is planned on aforementioned areas. SUN PF Secretariat has developed a survey questionnaire and it will be piloted and finalised in May 2015. Local CBOs will carry out the survey with the technical guidance of the SUN PF. A training on data collections for CBOs is scheduled towards the end of June 2015.

#### 5. Launch of Global Nutrition Report:

The SUN PF launched the Global Nutrition Report on 16<sup>th</sup> March 2015. The chief guest and the guest of honour at the launching ceremony was Hon. Minster of Health and Hon. State Minister of Children's affairs. A large number of stakeholders representing various government and non-governmental institutes including the Ministry of Health, Universities, United Nations Organizations, SUN PF and the media attended the event (Annex 4 - Photographs – Launch of Global Nutrition Report).

#### 6. Review of National Nutrition Policy:

As the first step of reviewing the national nutrition policy, a policy review committee

	was appointed in March 2015. SUN PF Secretariat drafted the Terms of Reference (ToR) for the policy review committee. The first meeting will be held in May 2015 (Annex 5 - ToR of the National Nutrition Policy Review Committee).	
7. #### Qualitative achievements against outcomes and results:

#### **Result of Outcome 1**

- At an average there was an 80 % member participation at the SUN PF council meetings.
  At all the council meetings, actions plans with timelines are prepared for the agreed
  activities. One of the significant developments at the meetings was that all the
  members attempt to complement each other by sharing their resource materials, best
  practices and other expertise.
- SUN PF Council Members provided a significant support for carrying out the project activities. The registration of local CBOs/NGOs at the district level was carried out with the support of council members. A survey of violation of breast milk code,

- advertisements related to food, dietary diversity and food security will be undertaken with the involvement of the council members.
- The Advocacy Plan for first 1000 days of nutrition was developed by the technical sub-committee of first 1000 days. It was a joint effort by both CSOs and MoH officials. In an environment where there is a stiff resistance by the government officials (Ministry of Health) over the engagement of civil society actors, to have agreed on the role of CSOs and to formulate an advocacy plan to eradicate malnutrition in Sri Lanka can be considered as a noteworthy achievement.
- SUN PF received recognition from the government by virtue of CEO of the SUN PF Secretariat being appointed as an advisor to the Minister of Child Development. In her advisory role now she has an opportunity to contribute towards addressing child malnutrition in Sri Lanka.

#### **Results of Outcome 2**

• SUN PF contributed to the task of developing the National School Meals program by being a member in the elite committee of professionals.

#### **Results of Outcome 3**

- The fact that SUN PF was given the privilege of launching the Global Nutrition Report indicates the recognition of its efforts towards addressing nutrition issues in Sri Lanka. While the event was graced by the Hon. Minister of Health and Hon. State Minister of Child Development, it was also attended by the Country Representative of UNICEF, Country Director of FAO, Deputy Country Director of WFP, Country Director of Save the Children International Sri Lanka, Country Director Plan International, several high officials representing the Ministry of Health and the media representatives.
- The launching event captured significant publicity through both electronic and print media giving widespread publicity to SUN PF and its work with CSOs. A few media links are given below:

- After introductions of council members, meeting was handed over to the Chairperson to proceed.

#### 2. Approve the minutes of the previous meeting

- The minutes of the previous meeting was approved subject to one amendment. Mr. V. Sutharsan, who participated from Worldvision, was not in the attendees list. It was added.
- Council Members inquired the stage of the registration with NGO Secretariat. Dr. Dula
  de Silva informed that the SUN PF has submitted the application but not received a
  response yet.
- Council was informed that certificates will be issued to the member in due course.
- Ms.Kanchana Weerakoon from ECHO-V asked whether ECHO-V is recognized as a member of Civil Society Alliance and the Secretariat informed that ECHO –V is a Council Member.
- Council members were informed the status of the SUN PF website. The Board of

  for SUN PF without any cost. It was mentioned that SUN PF is maintaining a Twitter and
  a Facebook page.

#### 3. Project progress of 2014

Presentation of the 2014 achievements of SUN project was presented and it was
highlighted the main achievements such as setting up SUN Executive Council,
establishing of SUN Secretariat. Also presented the status of membership drive,
established SUN PF Nutrition Committee at district level and Technical Subcommittee.
Further it was highlighted the current progress of development of advocacy plans of
three thematic areas and number of workshops conducted. The focus group discussions
(FGD) conducted by 1st Thousand Days Subcommittee will be used to develop advocacy
plan

#### 1. Welcome

The council meeting started at 10:15am. Dr. Dula De Silva welcomed the participants and invited Dr. D.S.N. Jayasundara to chair the meeting.

#### 2. Approval of the minutes of the previous meeting

Meeting minutes was tabled and approved without any changes.

#### 3. Way Forward

Council members decided to reappoint the new Council in June 2015 as the current council will complete its one year in June. It was decided to request Dr.Lalith Chandradasa to continue as an advisor in the Council.

Presented the activities plan for next 3 months:

- Launching the Global Nutrition Report
   This event is scheduled on the 16<sup>th</sup> of March 2015. The Institute of Development
   Studies will send the funds as SUN PF had selected to launch the report. SUN PF has
   planned to invite Minister of Health as the Chief Guest.
- Technical Expert Group will be appointed to review the National Nutrition Policy.
- Develop a video film of 4 to 5 minute duration showing the issues depicting the effects of poor nutrition with special focus on stunting, promoting appropriate complementary feeding, introducing food groups.
- The SUN PF will organize training programmes for members of SUN PF on monitoring existing nutrition interventions and reports, to interpret nutrition measurements, and operational research
- Organizing a SUN PF Day. The SUN PF hopes to hold this event in Diyatha Uyana, Battaramulla or in the Racecourse, Colombo 07 during April.

#### 4. Outcome of the 2<sup>nd</sup> Meeting of Board of Directors

Briefing on the outcomes of Meeting of the Board of Directors, Dr Dula de Silve said that the Board of Directors are happy about the achievements, which SUN PF has delivered within the six months in 2014. SUN PF will share the detailed financial progress as Board of Directors wanted the breakdown by activities.

#### 5. AOB

#### SUN PF's sustainability after 2015:

Mr. Methsiri de Silvas asked about the sustainability of SUN PF after 2015. Ms.
 Visakha Tillekeratne indicated that the three subcommittees should work properly to raise funds and also appoint a fourth fund raising subcommittee.

- Mr. Dave Maurice added that the SUN PF can consider future funding opportunities from EU as currently EU is requesting for CSO's interventions. The EU focuses to strengthen the Capacity of CSOs. The deadline is 23<sup>rd</sup> of March.
- Ms. Sadamali suggested that SUN PF can raise its funds by charging a membership fee

#### **Conflict of Interest Manual**

 Mr.Methsiri inquired about the Conflict of Interest guidelines. Dr Lalith Chandradasa mentioned this in the last Council Meeting and Dr Dula and Achala will work with Dr Lalith and give a PP at the next Council Meeting.

#### **SUN PF video documentary**

 Mr. Dave Maurice suggested that if the SUN PF is interested, it is possible to get the support from Right Frame Network who works with the USAID. It has developed about 200 audios, videos and documentaries related to good food, agriculture and nutrition. Council Members requested a meeting at the next Council meeting The conflict of interest of involving Mr Vasantha Dukganna Rala (VDR) was also stated.

#### Civil Society Alliance working with CSO in the field

- Ms. Visakha Tillekeratne said that Viluthu, where she is a consultant would like SUN
  PF to observe the interactive nutrition training workshops they conduct for
  communities at very low cost. She requested SUN PF to critic the training. The
  trainings are conducted by Viluthu are in Gomarankadawela and Echchalampattu.
- Mr. Dave Maurice mentioned that the mother support groups in the North, were
  informed to stop their food processing activities by PHIs if they do not have separate
  buildings and tiled floors. They were producing Jeewa Posha under micro credit
  project. It was suggested to appoint Mr.Madarasinghe as a consultant and give
  technical support for CBOs. Mr. Dave Murice said that Nucleus Foundation will take
  care of consultation charges.
- Ms. Visakha Tillekeratne suggested that SUN PF CSA can support the mother groups to conduct awareness programmes to introduce low cost food preparations and also make one dish meals and improve hygiene and sanitation.

#### Women's Day in Vavuniya and Visibility Event

- Mr. Dave Murice invited SUN PF to take part for Women Day organized in Vavuniya and organize the SUN PF day.
- Ms. Visakha Tillekeratne requested the Council to support newspaper supplements
  containing key nutrition messages for Women's Day. This will cost about \$ 1500.
  Also newspaper articles have been drafted. These would be circulated for comments
  and corrections.
- Ms.Visakha Thilakaratne suggested a visibility event, with a decorated Double
  Decker Bus carrying nutrition related messages. This should be organized to go
  around the Country.

#### **Build the link with Government**

- Mr. Dave Maurice suggested to communicate with the Government to inform about the SUN and write to SUN Global Committee nominating SUN PF as the Official SUN focal point
- The Council inquired about CSOs linkage with Government as National Nutrition
   Council do not exist anymore. Ms. Visakha Thilakaratne suggested that SUN Civil
   Society Alliance need to meet the Prime Minister and Minister of Policy Planning to
   discuss about the SUN and the Multi Sector Action Plan for Nutrition
- Ms Visaka suggested SUN PF to work closely with the Nationl Nutrition Society.

#### **Update of technical Subcommittees**

- Ms. Visakha Thilakaratne mentioned that Communication Advocacy Plan will be finalized by next council meeting and requested to include in the agenda.
- Ms. Achala Samaradivakara said that Food Security Advocacy plan will be finalized in next workshop.

MINUTES OF THE MEETING OF THE DIRECTORS OF SCALING UP NUTRITION PEOPLE'S FORUM (GUARANTEE) LIMITED HELD ON 18TH FEBRUARY 2015 AT 12.00 P.M. AT THE WFP CONFERENCE HALL #2, JAWATTA AVENUE, COLOMBO 05.

Mr. Suresh Bartlett was appointed as Pro-tem Chairman. The attendees were welcomed to the second meeting of the Directors of the Company.

#### 1. MINUTES -

The minutes of the previous meeting of the Directors held on 25th September 2014 were unanimously confirmed as a correct record and signed by the Chairman.

#### 2. MATTERS ARISING -

Chairman indicated that any matters that need to be followed up should be noted and that a check list should be made for the next meeting of the action that has been taken. Mr. Bartlett inquired from Dr. De Silva about the Financial Procedure Manual and was informed that this had been completed and was approved by the Council.

#### 3. PROGRAMME ACHIEVEMENTS -

#### 1. Achievements of Project Activities -

Mr. P. Welathanthry commenced a presentation on the SUN PF project. The Directors were informed that the SUN PF Secretariat was established and that the office was furnished and that there were three staff members. Mr. Welathanthry stated that the Council has agreed to accept the Global SUN Civil Society Alliance Good Governance Manual. Mr. Bartlett inquired about the practices adopted in other countries and Dr. De Silva informed that all countries connect once in two months to share information. He was also of the view that there would be more progress if all come together rather than a single movement doing their own 'thing'. The Partnership Agreement had been signed with Save the Children Sri Lanka. The Executive Council had been set up and consisted of nine non-governmental organisations and the first meeting had been held at the Presidential Secretariat. Six Executive Council meetings had been held during the period June - December 2014. World Vision holding the position of the Chair and Save the children being the Co-Chair.

The Board was informed that SUN Orientation workshops had been held in 11 districts with the active participation of the staff of the Government Agent's office. The workshops were conducted in each district with approximately 3-4 hours being spent to explain nutrition aspects at national and district level. The Puttlam district had not been covered as yet. 271 CBO's and NGO's joined the SUN PF in 2014 and SUN PF has set up District Nutrition Committee's in all 11 Districts. Dr. De Silva explained that the agenda for this year was to develop their capacity and mobilise them. The schedule of the SUN PF members were presented and the Directors noted that in addition to the 271 Civil Societies there were 10 Council members. The cost of conducting a workshop in a district was approximately Rs.100,000/= to Rs.150,000/= Dr. De Silva explained that funding was limited and this hampered the SUN PF from covering all the other districts.

The three Technical Sub-committee's were to develop advocacy plans for -

- 1. Improving food security, economics and nutrition (final stage)
- 2. Nutrition during 1st 1000 days (planning stage)

3. Communication for better nutrition (final stage) and it is expected to complete all three plans in March this year and a meeting is scheduled to be held on 26th/27th March to discuss the outcomes.

Mr. Welathanthry presenting another slide explained that SUN PF has worked with Partners to train the 271 CBO's and NGO's on Nutrition in the 11 districts, provided technical assistance to Consumer Voice – Sri Lanka, represented the civil societies at the National Nutrition Focal Point meetings and provided technical assistance to partner organisations. Chairman indicated that it was important to get the participation of the Family Health Bureau in all aspects and at all levels.

Commenting on Way Forward it is proposed to –

- 1. Launch the Global Nutrition Report as the Global Nutrition Alliance had sent the funds for the launch and they had requested that the Civil Society Alliance launch it. It is hoped to invite a few Ministers of the Government for the launch.
- 2. Appoint a technical expert group to review the implementation of the National Nutrition Policy and suggest relevant changes.
- 3. Develop a Documentary to improve nutrition. It was suggested that this be done in the Sinhala/Tamil languages with English sub titles.
- 4. Training SUN PF members to monitor existing nutrition interventions and reports, interpret nutrition measurements and operational research methodology.
- 5. To organize a SUN PF day during the Nutrition Month.
- 2. Financial Progress -

The statement on Cost Categories, Allocation, Expenses and Balances as at 31st December 2014 were presented and noted. Chairman indicated that the main expenditure line items for each 'Outcome' be shown in the future financial presentations. The Board was informed that monthly accounts were prepared and submitted to Save the Children and that the audit of accounts would commence soon after 31st March 2015.

#### 4. ANY OTHER BUSINESS -

Dr. De Silva was of the view that SUN PF had made a lot of progress and that everything was

going as planned. It is expected to conduct an awareness program for the media hopefully in March 2015. The Executive Council had suggested that a web site be developed and Dr. De Silva indicated that a young boy had volunteered to do it but the Directors cautioned against this as it would need to be constantly updated and monitored and suggested that it would be better to include data on Sri Lanka on the SUN Global web site rather than having a separate web site.

The SUN PF Annual Report was circulated to the Directors and Dr. De Silva requested that the Directors go through the Report and revert with their comments. It was suggested that a shorter version of it be recorded on a CD.

#### Annex 5 - ToR of the National Nutrition Policy Review Committee

#### **Draft Terms of References**

National Nutrition Policy Review Committee – SUN PF

Good nutrition is essential for development. The country has achieved almost all MDGs except nutrition targets. The National Nutrition Policy (NNP) for Sri Lanka was first developed in 1986. It was reviewed in 2010 and the existing NNP was endorsed by the Parliament in February 2010. The NNP was to be updated in 2013 and planned to be revised in 2018. However, the NNP was not updated in 2013. The SUN PF is given the task to review the implementation of the NNP and suggest the results to the government.

As revealed in the NNP the low birth weight prevalence is 16.6% (DHS 2006/2007), under 5 underweight 21.1%, under 5 wasting 14.1%, under 5 stunting 17.3%. The DHS 2006/2007 also showed significant geographical disparity. Still the National prevalence of low birthweight remains as 16%, under 5 underweight has increased to 23%, and stunting has fallen to 13%. The district disparity is still unacceptable, Nuwara Eliya stunting rate remains around 25%.

The NNP Policy Review Committee is expected to critically evaluate the policy under the following headings:

- 1. Topics the NNP cover
- 2. How they are being implemented
- 3. What is the implementation coverage
- 4. Who are the stakeholders
- 5. What Coordination Mechanism exist
- 6. How Monitoring and Evaluation are being implemented
- 7. Identify gaps in the design, contents and implementation
