

CAPE VERDE TRANSITION FUND

**Amendment No. 5 to the
Memorandum of Understanding
between
Participating United Nations Organizations,
the United Nations Resident Coordinator
and
the United Nations Development Programme
regarding the Operational Aspects of the Cape Verde Transition Fund**

WHEREAS, the Government of Cape Verde (hereinafter referred to as the "Government") has requested the members of the United Nations Country Team in Cape Verde (hereinafter referred to as the "UNCT"), under the leadership of the United Nations Resident Coordinator in Cape Verde, as the Co-Chair of the Steering Committee, as defined herein, (hereinafter referred to as the "Resident Coordinator"), to develop a single framework for their activities in support of national development priorities and accordingly the members of the UNCT have prepared a United Nations Development Assistance Framework in Cape Verde for 2012 - 2016 signed on 22 June 2012 (hereinafter referred to as the "One UN Programme"), as may be amended from time to time and attached hereto as ANNEX A;

WHEREAS, members of the UNCT signing this Memorandum of Understanding (hereinafter referred to collectively as the "Participating UN Organizations") have agreed that they should, under the leadership of the Resident Coordinator, adopt a coordinated approach to collaboration with donors who wish to support the implementation of the One UN Programme, and have developed a joint Cape Verde Transition Fund (hereinafter referred to as the "Transition Fund") to use as the basis for mobilizing resources for the One UN Programme; and have further agreed that they should offer donors the opportunity to contribute to the Transition Fund and receive reports on the Transition Fund through single channels;

WHEREAS, the Participating UN Organizations have agreed to establish a coordination mechanism (hereinafter referred to as the "Steering Committee"), co-chaired by the Resident Coordinator, to facilitate effective and efficient collaboration with the host Government for the oversight of the Transition Fund, and to be responsible for agreeing to the allocation and disbursement of funds, and where the Steering Committee cannot make a decision by consensus, the Resident Coordinator will make the ultimate decisions on fund allocation;

WHEREAS, the Participating UN Organizations have further agreed to ask the United Nations Development Programme (which is also a Participating UN Organization in connection with this Transition Fund) to serve as the administrative interface between the Donors and the Participating UN Organizations and for these purposes United Nations Development Programme has agreed to do so in accordance with this Memorandum of Understanding;

NOW, THEREFORE, the Participating UN Organizations, the Resident Coordinator and the United Nations Development Programme (hereinafter referred to collectively as the "Participants") hereby agree as follows:

The One UN Steering Committee and the UNCT have agreed to extend the duration of the programmes supported under the Transition Fund until 31 December 2020.

Accordingly, the Memorandum of Understanding between the Participating UN Organizations, the Resident Coordinator and the United Nations Development Programme, represented by its Multi-Partner Trust Fund Office acting as Administrative Agent of the "Transition Fund", is therefore modified as follows:

Preamble:

WHEREAS, members of the UNCT signing this Memorandum of Understanding Amendment No.5 (hereinafter referred to collectively as the "Participating UN Organizations") have agreed that they should, under the leadership of the Resident Coordinator, adopt a coordinated approach to collaboration with donors who wish to support the implementation of the One UN Programme, and have developed a United Nations Development Assistance Framework (UNDAF) in Cape Verde for 2012 - 2016 in support to the joint Cape Verde Transition Fund (hereinafter referred to as the "Transition Fund"), **starting on 1 July 2008 and ending on 31 December 2020**, to use as the basis for mobilizing resources for the One UN Programme; and have further agreed that they should offer donors the opportunity to contribute to the Transition Fund and receive reports on the Transition Fund through single channels;

All other terms and conditions of the Memorandum of Understanding and previous amendments remain unchanged.

IN WITNESS WHEREOF, the undersigned, duly authorized representatives of the respective Participants, have signed this Amendment No. 5 to the Memorandum of Understanding.
