Amendment No. 2 to the Memorandum of Understanding between Participating UN Organizations¹, and

the United Nations Development Programme regarding the Operational Aspects of a "Towards Unity in Action" MDTF in the Republic of Moldova

WHEREAS, the Participating United Nations Organizations signing this Memorandum of Understanding (hereinafter referred to collectively as the "Participating UN Organizations") have developed a "Towards Unity in Action" Multi-Donor Trust Fund starting on 1 February 2014 and ending on 31 December 2019 (hereinafter referred to as the "Fund"), as may be amended from time to time, as part of their respective development cooperation with the Government of the Republic of Moldova, as more fully described in the Terms of Reference of the Fund dated September 2013, (hereinafter referred to as the "TOR", a copy of which is attached hereto as ANNEX A, and have agreed to establish a coordination mechanism (hereinafter referred to as the "Steering Committee")² to facilitate the effective and efficient collaboration between the Participating UN Organizations and the host Government of the Republic of Moldova for the implementation of the Fund;

WHEREAS, the Participating UN Organizations have agreed that they should adopt a coordinated approach to collaboration with donors who wish to support the implementation of the Fund and have developed a TOR to use as the basis for mobilising resources for the Fund, and have further agreed that they should offer donors the opportunity to contribute to the Fund and receive reports on the Fund through a single channel; and

WHEREAS, the Participating UN Organizations have further agreed to ask the United Nations Development Programme (which is also a Participating UN Organization in connection with this Fund) to serve as the administrative interface between the donors and the Participating UN Organizations and for these purposes the United Nations Development Programme has agreed to do so in accordance with this Memorandum of Understanding.

WHEREAS, the Steering Committee meeting dated 05 December 2019 agreed to extend the duration of the programme "Confidence Building Measures Program in Transnistria-Health Sector, Phase 2" supported under the Fund until 31 March 2020.

NOW, THEREFORE, the Participating UN Organizations and the United Nations Development Programme (hereinafter referred to collectively as the "Participants") hereby agree as follows:


